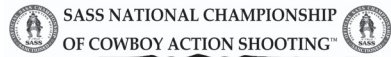

- To be included in printed literature Vendors fee and merchandise donation must be received before **February 01, 2011.**
- Vendors must participate for the full 5 days of the match and MAY NOT tear down before 2:00 PM Sunday.
- Dumpster are provided for trash. **Any Vendor leaving trash in their space will be charged a \$50 clean up fee.**
- On match days, **NO VEHICLES** on Sutler's Row, between 7:30 am & 5:30 PM.
- Vendors using their own tent may begin setup at 9:00 am Monday, February 21, 2011.
- Vendors using rental tents may begin setup at 11:00 am Monday, February 21, 2011.
- All tents must be white.**
- All Vendors must check in by 12:00 PM Tuesday, **February 22, 2011** or face forfeiture of their space.
- No alcoholic beverages are allowed WHEN THE RANGE IS OPEN. No glass containers are allowed.
- No pets are allowed in the Food Service Area, on the Firing Range or in the Main Tent.
- Violations of these rules may result in immediate ejection from Winter Range, or exclusion from future events.
